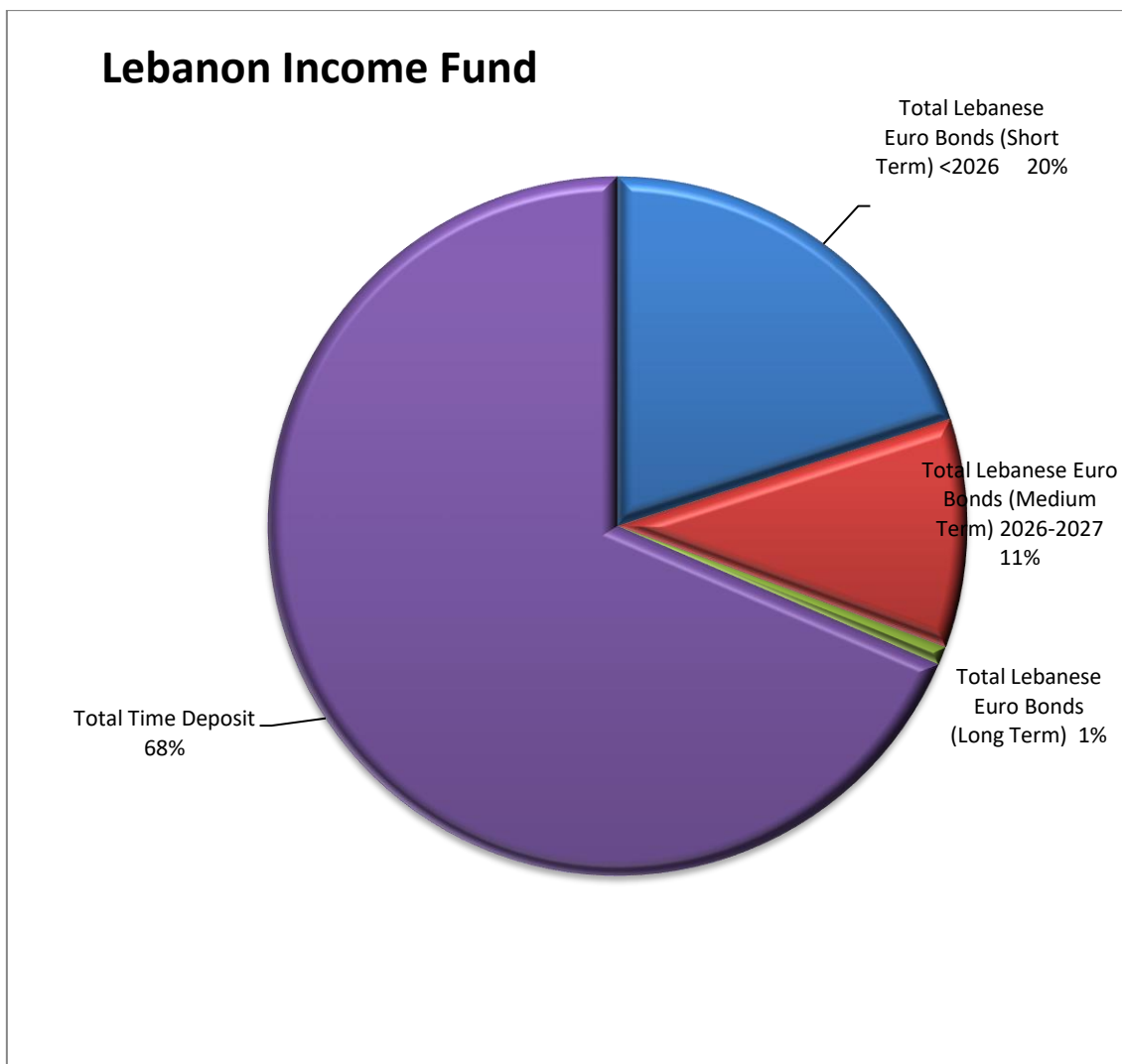
## INVESTMENT OBJECTIVE:

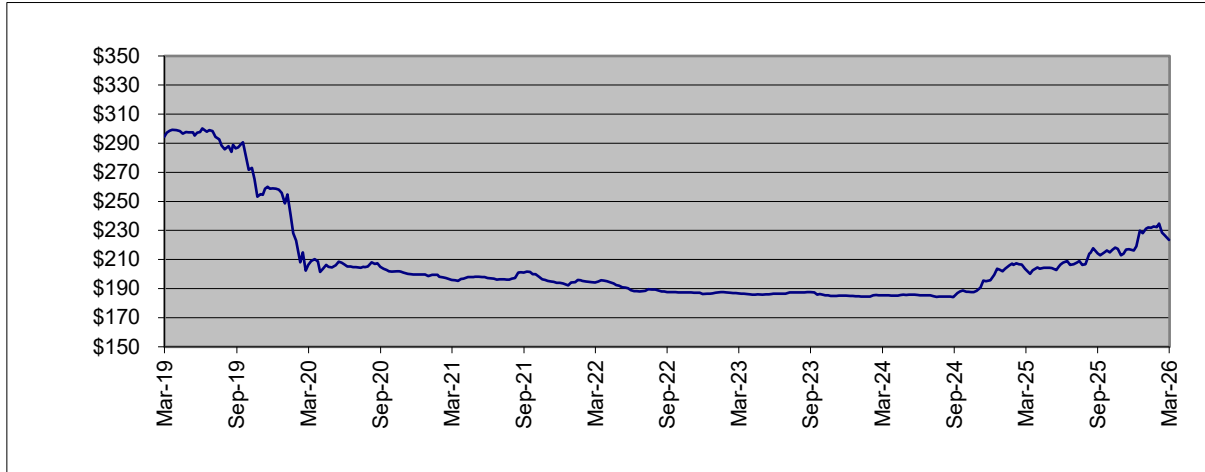
